VILLAGE OF EVANS MILLS **SEWER RATES**

Effective Q.E. August 31, 2019 the sewer rate will be \$65.00/unit/qtr.
Effective Q.E. May 31, 2021 the sewer rate will be \$75.00/unit/qtr.

VILLAGE OF EVANS MILLS **H2O DEBT CHARGES**

Effective Q.E. May 31, 2008 a new line item known as H2O Debt was established at a rate of \$2.50 per thousand gallons used. This fee was established to raise water revenues sufficient enough to produce funds to cover the annual debt on the new water storage tank. The charges for H2O Debt are based totally on usage and calculate on a quarterly basis. This charge will be the same for all users (Inside & Outside Village Corporate Limits).

VILLAGE OF EVANS MILLS **WATER RATE CHARGES**

Effective Q.E. Feb 28, 2021: Service charge for each dwelling or business unit with use of water up to 8,000 gallons per quarter year of \$40.00 (FORTY DOLLARS)

Effective Q.E. Feb 28, 2020: Any water usage over 8,000 gallons per unit per quarter year will be billed at **\$.00375** cents per gallon.

JOINT USE OF METERS:

Where two or more dwelling units, double houses, apartments in the same building or business, units on the same or adjoining premises are served by one meter, the minimum service charge shall apply to each unit.

CLASS #1 EFFECTIVE WITH BILLING FOR Q.E. FEB 28, 2021

CLASS #2 EFFECTIVE Q.E. FEB 28, 2020

Class #1 – Service charge for each dwelling or business unit with use of water up to 8,000 gallons per quarter year of \$80.00 (EIGHTY DOLLARS)

Class #2 – All water used over 8,000 gallons per unit per quarter year at **\$.00750** cents per gallon.
